Preliminary Damage Assessment Report

Pennsylvania – Remnants of Hurricane Ida **FEMÅ-4618-DR**

Declared September 10, 2021

On September 8, 2021, Governor Tom Wolf requested a major disaster declaration due to the remnants of Hurricane Ida during the period of August 31 to September 5, 2021. The Governor requested a declaration for Individual Assistance for six counties, Public Assistance for seven counties, and Hazard Mitigation for the entire commonwealth. During the period of September 5-8, 2021, joint federal, commonwealth, and local government Preliminary Damage Assessments (PDAs) were conducted in the requested counties and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the commonwealth and the affected local governments, and that Federal assistance is necessary.¹

On September 10, 2021, President Biden declared that a major disaster exists in the Commonwealth of Pennsylvania. This declaration made Individual Assistance requested by the Governor available to affected individuals and households in Bucks, Chester, Delaware, Montgomery, Philadelphia, and York Counties. This declaration also made Hazard Mitigation Grant Program assistance requested by the Governor available for hazard mitigation measures for the entire commonwealth.²

¹ The Preliminary Damage Assessment (PDA) process is a mechanism used to determine the impact and magnitude of damage and resulting needs of individuals, businesses, public sector, and community as a whole. Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

O Destroyed – total loss of structure, structure is not economically feasible to repair, or complete failure to major structural components (e.g., collapse of basement walls/foundation, walls or roof);

- o Major Damage substantial failure to structural elements of residence (e.g., walls, floors, foundation), or damage that will take more than 30 days to repair;
- Minor Damage home is damaged and uninhabitable, but may be made habitable in short period of time with repairs; and
- Affected some damage to the structure and contents, but still habitable.

The President has ultimate discretion and decision making authority to declare major disasters and emergencies under the Stafford Act (42 U.S.C. § 5170 and § 5191).
