# Preliminary Damage Assessment Report

## American Samoa – High Surf, High Winds, and Flooding FEMA-4669-DR

# Declared September 15, 2022

On August 12, 2022, Governor Lemanu P.S. Mauga requested a major disaster declaration due to high surf, high winds, and flooding during the period of July 12-15, 2022. The Governor requested a declaration for Individual Assistance, Public Assistance, and Hazard Mitigation for the territory of American Samoa. During the period of July 25 to August 8, 2022, joint federal, territory, and local government Preliminary Damage Assessments (PDAs) were conducted in the requested areas and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the territory and the affected local governments, and that Federal assistance is necessary.<sup>1</sup>

On September 15, 2022, President Biden declared that a major disaster exists in the territory of American Samoa. This declaration made Public Assistance requested by the Governor available to the territory and eligible local governments and certain private nonprofit organizations on a cost sharing basis for emergency work and the repair of replacement of facilities damaged by the high surf, high winds, and flooding in the territory of American Samoa. This declaration also made Hazard Mitigation Grant Program assistance requested by the Governor available for hazard mitigation measures for the territory of American Samoa.<sup>2</sup>

Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

Stafford Disaster Relief and Emergency Assistance Act, as amended (Stafford Act) is under review, a number of primary factors are considered to determine whether assistance is warranted. These factors are outlined in FEMA's regulations (44 CFR § 206.48). The President has ultimate discretion and decision making authority to declare major disasters and emergencies under the Stafford Act (42 U.S.C. § 5170 and § 5191).
