## Preliminary Damage Assessment Report

# Missouri – Severe Storms, Straight-line Winds, Tornadoes, and Flooding FEMA-4803-DR

### Declared July 23, 2024

On June 12, 2024, Governor Michael L. Parson requested a major disaster declaration due to severe storms, straight-line winds, tornadoes, and flooding during the period of May 19-27, 2024. The Governor requested a declaration for Individual Assistance for 10 counties, Public Assistance for 15 counties, and Hazard Mitigation statewide. During the period of June 3-11, 2024, joint federal, state, and local government Preliminary Damage Assessments (PDAs) were conducted in the requested areas and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the state and the affected local governments, and that Federal assistance is necessary.<sup>1</sup>

On July 23, 2024, President Biden declared that a major disaster exists in the State of Missouri. This declaration made Individual Assistance requested by the Governor available to affected individuals and households in Barry, Butler, Carter, Howell, New Madrid, Ripley, Scott, Shannon, Stoddard, and Texas Counties. This declaration also made Public Assistance requested by the Governor available to state and eligible local governments and certain private nonprofit organizations on a cost-sharing basis for emergency work and the repair or replacement of facilities damaged by severe storms, straight-line winds, tornadoes, and flooding in Barry, Bollinger, Butler, Carter, Howell, Madison, McDonald, New Madrid, Oregon, Reynolds, Ripley, Scott, Shannon, Stoddard, and Texas Counties. Finally, this declaration also made Hazard Mitigation Grant Program assistance requested by the Governor available for hazard mitigation measures statewide.<sup>2</sup>

Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

Stafford Disaster Relief and Emergency Assistance Act, as amended (Stafford Act) is under review, a number of primary factors are considered to determine whether assistance is warranted. These factors are outlined in FEMA's regulations (44 CFR § 206.48). The President has ultimate discretion and decision making authority to declare major disasters and emergencies under the Stafford Act (42 U.S.C. § 5170 and § 5191).

o Major Damage – substantial failure to structural elements of residence (e.g., walls, floors, foundation), or damage that will take more than 30 days to repair;

o Affected – some damage to the structure and contents, but still habitable.
