10. Program Overview, Objectives, and Priorities

a. Overview

The purpose of the FY 2021 EMBAG is to develop, maintain and update, and test national-level standards for emergency management that can help ensure that jurisdictions (state, tribal, territorial, and local communities) have accredited emergency management programs and certified emergency management professionals in place in advance of an incident. To achieve this purpose, the EMBAG supports voluntary national-level standards and peer review assessment processes that jurisdictions can use to identify the capacity and shortfalls of their emergency management programs and professionals and develop a path to compliance. These national-level standards fall under "other assistance" called out under Section 503 (b)(2)(G) of the Homeland Security Act of 2002 to "build tribal, local, State, regional, and national capabilities…necessary to respond to a natural disaster, act of terrorism, or other man-made disaster."

The EMBAG specifically supports:

1. The development, maintenance, update, revision, and enhancement of voluntary national-level standards and peer review assessment processes for emergency

- preparedness and response that are driven, established, validated, and revised through consensus;
- 2. Related efforts to develop or update national-level accreditation for these standards; and
- 3. The assessment of select state, local, tribal, and territorial emergency management programs and professionals against these national-level standards.

The EMBAG aligns to the FY 2020-2024 DHS Strategic Plan, Presidential Policy Directive 8 (PPD-8), and DHS/FEMA's (FEMA's) mission and 2018-2022 Strategic Plan. The EMBAG specifically addresses Goal 5, Objective 5.1 of the FY 2020-2024 DHS Strategic Plan to strengthen preparedness and resilience by building a national culture of preparedness. The EMBAG program aligns to PPD-8 through supporting national-level standards and assessment processes that emergency management programs and professionals can use to improve their preparedness capabilities to prevent, protect against, mitigate the effect of, respond to, and recover from the threats that pose the greatest risk to the security of the Nation. In addition, the EMBAG program reinforces DHS/FEMA's (FEMA's) mission of advancing all-hazards preparedness, which is driven by the Post-Katrina Emergency Management Reform Act of 2006 (PKEMRA). The EMBAG program supports the FEMA 2018-2022 Strategic Plan through the following goals and their objectives:

b. *Objectives*

The EMBAG program supports investment in national-level standards for emergency management that target critical functions necessary to prepare for and manage disasters, with the goal of supporting the following short and long-term outcomes:

- In the short to mid-term, jurisdiction emergency management programs participating in the EMBAG achieve compliance with national-level standards for critical functions necessary to prepare for and manage disasters. Long-term, these programs increase their preparedness to manage disasters.
- In the short to mid-term, emergency management professionals tied to jurisdiction emergency management programs and participating in the EMBAG achieve compliance with national-level standards for critical functions necessary to manage

emergency management programs. Long-term, these professionals increase their capability to manage these programs during disasters.

To achieve these outcomes, the FY 2021 EMBAG program provides funding for two (2) objectives, which together include five (5) projects. These objectives, their projects, and detailed requirements for project activities are described in the table below. These objectives are described in further detail in Appendix H: Guidance for Data Collection and Continuity Assessment Tool Activities of this NOFO.

Applicants are encouraged to propose and provide support for the inclusion of the key considerations and practices of the Threat, Hazard, and Risk Identification and Assessment (THIRA) as part of the national-level standards for emergency management program accreditation. Applicants should also ensure these standards are aligned with the following FEMA doctrine and policy documents, also outlined and described in Appendix A: FEMA Expectations for Standards Alignment and Assessment Review:

The criterion defining eligible nonprofit organizations and institutes of higher education is based on demonstrating competence in emergency management program accreditation and/or emergency management professional certification and is defined under the **Applicant Eligibility Criteria** header below.

2. Applicant Eligibility Criteria

The criteria that organizations must meet in order to be eligible for the EMBAG are defined below. Applicants that do not meet eligibility and application submission requirements will not be evaluated and scored by the review panel.

Eligible nonprofit organizations and institutes of higher education must be able to demonstrate, for either emergency management program accreditation AND/OR emergency management professional certification, that they are qualified to develop, update, revise, and enhance national-level standards for emergency management and implement assessments against them for emergency management programs AND/OR emergency management professionals, according to questions defined in Appendix D: Project Narrative Template. Applicants will demonstrate their experience and expertise (and that of their partner organization, if applicable according to information under the Other EMBAG-Specific Application Information header below) using the questions in Appendix D: Project Narrative Template, and reviewers will use these questions as one set of criteria to score applications as outlined in Appendix E: Evaluation and Scoring Criteria.

Any standard relating to emergency management program accreditation AND/OR emergency management professional certification AND that has been accredited by a national-level accreditation body for standards can satisfy this eligibility criterion. Additional information is contained in Section E: Application Review Information, Appendix D: Project Narrative Template, and Appendix E: Evaluation and Scoring Criteria.

3. Other Eligibility Criteria

a. Other Program-Specific Application Information

Applicants may partner with one (1) other eligible organization, but only one (1) applicant may apply for and receive an award and the applicant must apply on behalf of the partner organization. If applicants choose to partner with another organization, they may issue only one (1) subaward to the organization with which they have chosen to partner under the recipient's EMBAG award. Eligible beneficiaries of this grant are state, local, tribal, and territorial emergency management programs and professionals.

Applications must conform to the guidance provided in <u>Appendix D: Project Narrative Template</u> of this NOFO. Applications will be evaluated using a scoring rubric, which is described in <u>Section E: Application Review Information</u> and <u>Appendix E: Evaluation and Scoring Criteria</u>.

The following eligibility criteria apply for projects submitted as part of this application:

All entities applying for funding, including renewal funding, must have a DUNS number from Dun & Bradstreet (D&B). Applicants must enter the DUNS number in the data entry field labeled "Organizational DUNS" on the SF-424 form.

Note: At some point, the DUNS Number will be replaced by a "new, non-proprietary identifier" requested in, and assigned by, SAM.gov. This new identifier is being called the Unique Entity Identifier (UEI), or the Entity ID. Grants.gov has begun preparing for this transition by educating users about the upcoming changes and updating field labels and references to the DUNS Number (the current identifier) within the Grants.gov system. I. ADDITIONAL SAM REMINDERS

Please allow plenty of time before the grant application submission deadline to obtain a DUNS number and then to register in SAM. I. Electronic Signature:

When applications are submitted through Grants.gov, the name of the organization applicant with the AOR role that submitted the application is inserted into the signature line of the application, serving as the electronic signature. The EBiz POC must authorize individuals who are able to make legally binding commitments on behalf of the organization as an AOR; this step is often missed, and it is crucial for valid and timely submissions.

7. How to Submit an Initial Application to FEMA via Grants.gov Standard Form 424 (SF-424) is the initial application for this NOFO.

Grants.gov applicants can apply online using a workspace. A workspace is a shared, online environment where members of a grant team may simultaneously access and edit different web forms within an application. For each Notice of Funding Opportunity, you can create individual instances of a workspace. The forms are designed to fill in common required fields across other forms, such as the applicant name, address, and DUNS number. To trigger this feature, an applicant must complete the SF-424 information first. Once it is completed, the information will transfer to the other forms.

f. Submit a Workspace:

An application may be submitted through workspace by clicking the "Sign and Submit" button on the Manage Workspace page, under the Forms tab. Grants.gov recommends submitting your application package at least 24-48 hours prior to the close date to provide you with time to correct any potential technical issues that may disrupt the application submission.

g. Track a Workspace:

After successfully submitting a workspace package, a Grants.gov Tracking Number (GRANTXXXXXXX) is automatically assigned to the application. The number will be listed on the confirmation page that is generated after submission. As application submission is a two-step process, the applicant with the AOR role who submitted the application in Grants.gov will receive an acknowledgement of receipt and a tracking number (GRANTXXXXXXXXX) from Grants.gov with the successful transmission of its initial application. **This notification does not serve as proof of timely submission, as the application is not complete until it is submitted in ND Grants.** Applicants can also view the ND Grants Agency Tracking Number by accessing the Details tab in the submitted workspace section in Grants.gov, under the Agency Tracking Number column. Should the Agency Tracking Number not appear, the application has not yet migrated from Grants.gov into the ND Grants System. Please allow 24 hours for your ND Grants application tracking number to migrate.

All applications must be received in ND Grants by **5:00 PM ET** on the application deadline. Proof of timely submission is automatically recorded by ND Grants. An electronic date/time stamp is generated within the system when the application is successfully received by ND Grants. Additionally, the applicant(s) listed as contacts on the application will receive a system-generated email to confirm receipt.

13. Funding Restrictions and Allowable Costs

All costs charged to awards covered by this NOFO must comply with the Uniform Administrative Requirements, Cost Principles, and Audit Requirements at 2 C.F.R. Part 200, unless otherwise indicated in the NOFO, or the terms and conditions of the award. This includes, among other requirements, that costs must be incurred, and products and services must be delivered, within the period of performance of the award. *See* 2 C.F.R. § 200.403(h) (referring to budget periods, which for FEMA awards is the same as the period of performance).

In general, the Cost Principles establish standards for the allowability of costs, provide detailed guidance on the cost accounting treatment of costs as direct or administrative costs, and set forth allowability principles for selected items of cost. More specifically, except as otherwise stated in this NOFO, the terms and condition of an award, or other program materials, costs charged to awards covered by this NOFO must be consistent with the Cost Principles for Federal Awards located at 2 C.F.R. Part 200, Subpart E. In order to be allowable, all costs charged to a FEMA award or applied to the cost share must be reasonable in nature and amount and allocable to the particular FEMA award.

Additionally, all costs charged to awards must comply with the grant program's applicable statutes, policies, requirements in this NOFO as well as with the terms and conditions of the award. If FEMA staff identify costs that are inconsistent with any of these requirements, these costs may be disallowed, and FEMA may recover funds as appropriate, consistent with applicable laws, regulations, and policies.

As part of those requirements, grant recipients and subrecipients may only use federal funds or funds applied to a cost share for the purposes set forth in this NOFO and the terms and conditions of the award, and those costs must be consistent with the statutory authority for the award.

Grant funds may not be used for matching funds for other federal grants/cooperative agreements, lobbying, or intervention in federal regulatory or adjudicatory proceedings. In addition, federal funds may not be used to sue the federal government or any other government entity.

Recipients are also expected to conform, as applicable, with accepted engineering practices, established codes, standards, modeling techniques, and best practices, and participate in the development of case studies demonstrating the effective use of grant funds, as requested.

a. Prohibitions on Expending FEMA Award Funds for Covered Telecommunications Equipment or Services

Recipients and subrecipients of FEMA federal financial assistance are subject to the prohibitions described in section 889 of the John S. McCain National Defense Authorization Act for Fiscal Year 2019 (FY 2019 NDAA), Pub. L. No. 115-232 (2018) and 2 C.F.R. §§ 200.216, 200.327, 200.471, and Appendix II to 2 C.F.R. Part 200. Beginning August 13, 2020, the statute – as it applies to FEMA recipients, subrecipients, and their contractors and subcontractors – prohibits obligating or expending federal award funds on certain telecommunications and video surveillance products and contracting with certain entities for national security reasons.

Additional guidance is available at <u>Prohibitions on Expending FEMA Award Funds for</u> Covered Telecommunications Equipment or Services (Interim) FEMA Policy #405-143-1.

Effective August 13, 2020, FEMA recipients and subrecipients may not use any FEMA funds under open or new awards to:

- (1) Procure or obtain any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology of any system;
- (2) Enter into, extend, or renew a contract to procure or obtain any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology of any system; or
- (3) Enter into, extend, or renew contracts with entities that use covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system.

I. DEFINITIONS

Per section 889(f)(2)-(3) of the FY 2019 NDAA and 2 C.F.R. § 200.216, covered telecommunications equipment or services means:

- i. Telecommunications equipment produced by Huawei Technologies Company or ZTE Corporation, (or any subsidiary or affiliate of such entities);
- ii. For the purpose of public safety, security of Government facilities, physical security surveillance of critical infrastructure, and other national security purposes, video surveillance and telecommunications equipment produced by Hytera Communications Corporation, Hangzhou Hikvision Digital Technology Company, or Dahua Technology Company (or any subsidiary or affiliate of such entities):
- iii. Telecommunications or video surveillance services provided by such entities or using such equipment; or
- iv. Telecommunications or video surveillance equipment or services produced or provided by an entity that the Secretary of Defense, in consultation with the Director of National Intelligence or the Director of the Federal Bureau of

Investigation, reasonably believes to be an entity owned or controlled by, or otherwise connected to, the People's Republic of China.

Examples of the types of products covered by this prohibition include phones, internet, video surveillance, and cloud servers when produced, provided, or used by the entities listed in the definition of "covered telecommunications equipment or services." *See* 2 C.F.R. § 200.471.

b. Pre-Award Costs

Pre-award costs are **NOT** allowable.

c. Management and Administration (M&A) Costs

M&A activities are those directly relating to the management and administration of the EMBAG funds, such as financial management and monitoring. M&A costs are not operational costs. They are the necessary costs incurred in direct support of the grant or as a consequence of the grant and should be allocated across the entire lifecycle of the grant. Recipients may retain a maximum of five (5) percent of EMBAG funds awarded for M&A purposes associated with the EMBAG award. An organization partnering with a recipient (limit one per recipient) may in turn retain five (5) percent of the sub-award they receive from the recipient for M&A purposes.

d. Indirect Facilities & Administrative (F&A) Costs

Indirect costs are allowable under this program as described in 2 C.F.R. Part 200, including 2 C.F.R. § 200.414. Applicants with a current negotiated indirect cost rate agreement that desire to charge indirect costs to an award must provide a copy of their negotiated indirect cost rate agreement at the time of application. Not all applicants are required to have a current negotiated indirect cost rate agreement. Applicants that are not required by 2 C.F.R. Part 200 to have a negotiated indirect cost rate agreement but are required by 2 C.F.R. Part 200 to develop an indirect cost rate proposal must provide a copy of their proposal at the time of application. Applicants who do not have a current negotiated indirect cost rate agreement (including a provisional rate) and wish to charge the de minimis rate must reach out to the FEMA Program Analyst and Grants Management Specialist for further instructions. Applicants who wish to use a cost allocation plan in lieu of an indirect cost rate must also reach out to the FEMA Program Analyst, Grants Management Specialist, or other relevant FEMA position for further instructions. Post-award requests to charge indirect costs will be considered on a case-by-case basis and based upon the submission of an agreement or proposal as discussed above or based upon on the de minimis rate or cost allocation plan, as applicable.

Organization-related costs are NOT allowed under this program.

Equipment

Equipment costs are **NOT** allowed under this program.

Training

Training-related costs **are allowed** under this program only as described in this NOFO. Please refer to <u>Appendix C: Detail of Allowable and Not Allowable Direct Costs Under EMBAG</u> of this NOFO for additional information.

Exercises

Exercise-related costs **are allowed** under this program only as described in this NOFO. Please refer to <u>Appendix C: Detail of Allowable and Not Allowable Direct Costs Under EMBAG</u> of this NOFO for additional information.

Personnel

Personnel costs **are allowed** under this program for the applicant (and its partner, if applicable) only as described in this NOFO, with the following exceptions:

Hiring additional personnel to complete the process of peer review is **NOT allowed**.

Contract and consulting costs are allowed for management of grant awards.

Contract and consulting costs **are NOT allowed** for providing subject-matter expertise on the FY 2021 EMBAG Objectives.

Travel

Domestic travel costs are allowed under this program only as described in this NOFO.

Construction and renovation costs are **NOT** allowed under this program.

E. Application Review Information

1. Application Evaluation Criteria

a. Programmatic Criteria

Applications must conform with the guidance provided in this section, Section D:

Application and Submission Information, and Appendix D: Project Narrative Template.

FY 2021 EMBAG applications will also be evaluated for completeness, adherence to programmatic guidelines, and anticipated effectiveness of the proposed project. Only the applicant may submit an application. If the applicant is partnering with another organization, they must submit information pertaining to their partner in their application on behalf of their partner.

Below is a summary of the evaluation criteria. The full criteria are found in <u>Appendix E:</u> <u>Evaluation and Scoring Criteria</u>, which details the specific criteria aligned to four (4) of the five (5) Project Narrative requirements and the maximum number of points an application can receive for each criterion. The four (4) base criteria earn up to 100 total possible points. Each base criterion contains two (2) questions and subparts that applicants (and their partner, if applicable) must address in their Project Narrative. FEMA will not review applications that do not address all questions and subparts.

- <u>Demonstration of Experience and Expertise</u>: The applicant demonstrates that both it and any partner organization possess the experience and expertise necessary to carry out the objectives of the FY 2021 EMBAG.
 - Questions align to criteria in Section C: Eligibility Information.
 - Applicants (and their partner, if applicable) will receive a higher score according to the scoring criteria in <u>Appendix E: Evaluation and Scoring Criteria</u> if they demonstrate through their Project Narrative that they are qualified to develop, update, revise, and enhance standards accredited by the <u>American National Standards Institute (ANSI)</u> or an equivalent North American accreditation or certification body that is a member body of the <u>International Organization for Standardization (ISO)</u>.
 - (Possible Points: 0 20 maximum; a satisfactory score is 15 points, with up to 5 additional points possible if narrative demonstrates applicant is qualified to develop, update, revise, and enhance standards accredited by <u>ANSI</u> or an equivalent North American accreditation or certification body that is a member body of the <u>ISO</u>)
- <u>Project Plan</u>: The applicant describes (on behalf of themselves and their partner, if applicable) an effective plan that meets all objectives and priorities of the FY 2021 EMBAG and addresses its post-award requirements.
 - Questions align to the EMBAG objectives described in <u>Section A: Program Description</u> and <u>Appendix G: Post-Award Requirements</u>.
 - Questions also address guidance in <u>Appendix A: FEMA Expectations for Standards Alignment and Assessment Review, Appendix G: Post-Award Requirements, and Appendix H: Guidance for Data Collection and Continuity Assessment Tool Activities.</u>
 - EMBAG priorities are further described in <u>Appendix A: FEMA Expectations</u> for Standards Alignment and Assessment Review.
 - In order to receive a satisfactory score, applicants (and if applicable, their

- partner) must complete at least one (1) objective and one (1) project, which are defined in Section A: Program Description.
- The objective and projects that each organization completes can be different.
- If applicants (and their partner, if applicable) propose more than (1) objective and one (1) project, they will receive a higher score by the Application Review panel.
- To receive a satisfactory score, applicants must also describe how they (and their partner, if applicable) will meet the post-award reporting and workplan requirements described in Appendix G: Post-Award Requirements. The Project Plan that applicants submit (on behalf of themselves and their partner, if applicable) as part of their Project Narrative will be considered the draft workplan if the applicant is selected as a recipient, and recipients will use it to update and finalize their workplan after they accept the award, as described in Appendix G: Post-Award Requirements.
- Additional information is contained in <u>Appendix E: Evaluation and Scoring</u> Criteria.
- (Possible points: 0 30 maximum; satisfactory score is 22 points, with up to 2 points possible for each additional EMBAG Objective Project addressed)
- <u>Impact</u>: The applicant demonstrates the impact of their proposed plan on the emergency management community, jurisdictions, and national preparedness (on behalf of themselves and their partner, if applicable).
 - Questions align to the EMBAG purpose and performance metrics described in Section A: Program Description.
 - (Possible points: 0 30 maximum)
- <u>Budget</u>: The applicant demonstrates a reasonable and cost-effective budget, including an explanation of project costs and relative cost effectiveness across the requested categories, and their ability as an applicant to manage federal grants (on behalf of themselves and their partner, if applicable).
 - Applicants must also complete a Budget Detail Worksheet according to Appendix F: Budget Detail Worksheet Template.
 - (Possible Points: 0 20 maximum)

b. Financial Integrity Criteria

Prior to making a federal award, FEMA is required by 31 U.S.C. § 3354, as enacted by the Payment Integrity Information Act of 2019, Pub. L. No. 116-117 (2020); 41 U.S.C. § 2313; and 2 C.F.R. § 200.206 to review information available through any Office of Management and Budget (OMB)-designated repositories of governmentwide eligibility qualification or financial integrity information, including whether the applicant is suspended or debarred. FEMA may also pose additional questions to the applicant to aid in conducting the pre-award risk review. Therefore, application evaluation criteria may include the following risk-based considerations of the applicant:

- i. Financial stability.
- ii. Quality of management systems and ability to meet management standards.
- iii. History of performance in managing federal award.

- iv. Reports and findings from audits.
- v. Ability to effectively implement statutory, regulatory, or other requirements.

c. Supplemental Financial Integrity Criteria and Review

Prior to making a federal award where the anticipated total federal share will be greater than the simplified acquisition threshold, currently \$250,000:

- i. FEMA is required to review and consider any information about the applicant, including information on the applicant's immediate and highest-level owner, subsidiaries, and predecessors, if applicable, that is in the designated integrity and performance system accessible through the System for Award Management (SAM), which is currently the Federal Awardee Performance and Integrity Information System (FAPIIS).
- ii. An applicant, at its option, may review information in FAPIIS and comment on any information about itself that a federal awarding agency previously entered.
- iii. FEMA will consider any comments by the applicant, in addition to the other information in FAPIIS, in making a judgment about the applicant's integrity, business ethics, and record of performance under federal awards when completing the review of risk posed by applicants as described in 2 C.F.R. § 200.206.

2. Review and Selection Process

Initial Eligibility Review

Prior to application consideration, FEMA will conduct an initial review of all applications to verify applicant (and partner organization, if applicable) eligibility and ensure each application is complete. FEMA will not process incomplete applications for further review and will not consider them for funding. All eligible and complete applications will progress to the applicable FEMA program office for further review. FEMA staff will review the following during the eligibility screening:

- a. The applicant and their partner organization, if applicable, are eligible organizations as defined under the Eligible Applicants header of <u>Eligibility Information</u> of this NOFO and conform to the Eligibility Criteria in Section C of this NOFO, above.
- b. The applicant has submitted all required assurances and standard forms.
- c. The application complies with the Application Submission information presented in <u>Section D: Application and Submission Information</u> and <u>Appendix D: Project Narrative Template</u>, and:
 - Application includes a Project Narrative that aligns with the format requirements specified in <u>Appendix D: Project Narrative Template</u>.
 - Application includes a Budget Detail Worksheet (<u>Appendix F: Budget Detail Worksheet Template</u>).

Review Panel

Applications will be reviewed and scored by a review panel comprised of personnel from FEMA. Applicants (and partners, if applicable) that do not meet eligibility and application submission requirements will not be evaluated and scored by the review panel. The review panel will score applications based on specific criteria described in Appendix E: Evaluation and Scoring Criteria and aligned to the requirements outlined under the Application Evaluation Criteria header of this section, Section D: Application and Submission Information and Application will be reviewed by no less than two reviewers. The review panel will score applications based on the evaluation criteria, taking into consideration completeness, adherence to programmatic guidelines, and anticipated effectiveness of the plan proposed in the Project Plan section of the Project Narrative.

<u>Application Selection Process</u>

FEMA staff will make recommendations based on scores assigned by the application review panel, which will be sorted in descending order from the highest score to lowest score until as many EMBAG Objective Projects possible are addressed.

FEMA senior leadership will review recommended awards based on the results of the ranked application scores. Final funding determinations will be made by the Administrator of FEMA. A maximum of four applicants will be selected.

Required Application Contents

Applicants must present the contents of the application using the following arrangement (on behalf of themselves and their partner, if applicable). Applicants should refer to <u>Appendix E:</u> Evaluation and Scoring Criteria for additional details.

- Background
- Demonstration of Experience and Expertise
- Project Plan
- Impact
- Budget

Applicants should not include any Classified or Law Enforcement Sensitive information in their applications for this program.

F. Federal Award Administration Information

1. Notice of Award

Before accepting the award, the AOR and recipient should carefully read the award package. The award package includes instructions on administering the grant award and the terms and conditions associated with responsibilities under federal awards. Recipients must accept all conditions in this NOFO as well as any specific terms and conditions in the Notice of Award to receive an award under this program.

Notification of award approval is made through the ND Grants system through an automatic electronic mail to the recipient's authorized official listed in the initial application. The recipient should follow the directions in the notification to confirm acceptance of the award.

Recipients must accept their awards no later than 60 days from the award date. The recipient shall notify FEMA of its intent to accept and proceed with work under the award or provide a notice of intent to decline through the ND Grants system. For instructions on how to accept or decline an award in the ND Grants system, please see the ND Grants Grant Recipient User Guide, which is available at https://www.fema.gov/grants/guidance-tools/non-disaster-grants-management-system along with other ND Grants materials.

Funds will remain on hold until the recipient accepts the award through the ND Grants system and all other conditions of the award have been satisfied or until the award is otherwise rescinded. Failure to accept a grant award within the 60-day timeframe may result in a loss of funds.

2. Pass-Through Requirements

3. Administrative and National Policy Requirements

b. Ensuring the Protection of Civil Rights

As the Nation works towards achieving the <u>National Preparedness Goal</u>, it is important to continue to protect the civil rights of individuals. c. Closeout Reporting Requirements

I. CLOSEOUT REPORTING

Within 120 days after the end of the period of performance for the prime award or after an amendment has been issued to close out an award before the original POP ends, recipients must liquidate all financial obligations and must submit the following:

- i. The final request for payment, if applicable.
- ii. The final FFR (SF-425).
- iii. The final progress report detailing all accomplishments, including a narrative summary of the impact of those accomplishments throughout the period of performance.
- iv. Other documents required by this NOFO, terms and conditions of the award, or other FEMA guidance.

If applicable, an inventory of all construction projects that used funds from this program must be reported with the final progress report.

In addition, pass-through entities are responsible for closing out their subawards as described in 2 C.F.R. § 200.344; subrecipients are still required to submit closeout materials within 90 days of the period of performance end date. When a subrecipient completes all closeout requirements, pass-through entities must promptly complete all closeout actions for subawards in time for the recipient to submit all necessary documentation and information to FEMA during the closeout of the prime award.

After the prime award closeout reports have been reviewed and approved by FEMA, a closeout notice will be completed to close out the grant. The notice will indicate the period of performance as closed, list any remaining funds that will be deobligated, and address the requirement of maintaining the grant records for at least three years from the date of the final FFR. The record retention period may be longer, such as due to an audit or litigation, for equipment or real property used beyond the period of performance, or due to other circumstances outlined in 2 C.F.R. § 200.334.

The recipient is responsible for refunding to FEMA any balances of unobligated cash that FEMA paid that are not authorized to be retained per 2 C.F.R. § 200.344(d).

In addition, any recipient that issues subawards to any subrecipient is responsible for closing out those subawards as described in 2 C.F.R. § 200.343. Recipients acting as pass-through entities must ensure that they complete the closeout of their subawards in time to submit all necessary documentation and information to FEMA during the closeout of their prime grant award.

II. ADMINISTRATIVE CLOSEOUT

Administrative closeout is a mechanism for FEMA to unilaterally move forward with closeout of an award using available award information in lieu of final reports from the recipient per 2 C.F.R. § 200.344(h)-(i). It is a last resort available to FEMA, and if FEMA needs to administratively close an award, this may negatively impact a recipient's ability to obtain future funding. This mechanism can also require FEMA to make cash or cost

adjustments and ineligible cost determinations based on the information it has, which may result in identifying a debt owed to FEMA by the recipient.

When a recipient is not responsive to FEMA's reasonable efforts to collect required reports needed to complete the standard closeout process, FEMA is required under 2 C.F.R. § 200.344(h) to start the administrative closeout process within the regulatory timeframe. FEMA will make at least three written attempts to collect required reports before initiating administrative closeout. If the recipient does not submit all required reports in accordance with 2 C.F.R. § 200.344, this NOFO, and the terms and conditions of the award, FEMA must proceed to administratively close the award with the information available within one year of the period of performance end date. Additionally, if the recipient does not submit all required reports within one year of the period of performance end date, per 2 C.F.R. § 200.344(i), FEMA must report in FAPIIS the recipient's material failure to comply with the terms and conditions of the award.

If FEMA administratively closes an award where no final FFR has been submitted, FEMA uses that administrative closeout date in lieu of the final FFR submission date as the start of the record retention period under 2 C.F.R. § 200.334.

In addition, if an award is administratively closed, FEMA may decide to impose remedies for noncompliance per 2 C.F.R. § 200.339, consider this information in reviewing future award applications, or apply special conditions to existing or future awards.

d. Additional Reporting Requirements

I. DISCLOSING INFORMATION PER 2 C.F.R. § 180.335

This reporting requirement pertains to disclosing information related to government-wide suspension and debarment requirements. Before a recipient enters into a grant award with FEMA, the recipient must notify FEMA if it knows if it or any of the recipient's principals under the award fall under one or more of the four criteria listed at 2 C.F.R. § 180.335:

- i. Are presently excluded or disqualified;

- iv. Have had one or more public transactions (federal, state, or local) terminated within the preceding three years for cause or default.

At any time after accepting the award, if the recipient learns that it or any of its principals falls under one or more of the criteria listed at 2 C.F.R. § 180.335, the recipient must provide immediate written notice to FEMA in accordance with 2 C.F.R. § 180.350.

II. REPORTING OF MATTERS RELATED TO RECIPIENT INTEGRITY AND PERFORMANCE Per 2 C.F.R. Part 200, Appendix I § F.3, the additional post-award reporting requirements in 2 C.F.R. Part 200, Appendix XII may apply to applicants who, if upon becoming recipients, have a total value of currently active grants, cooperative agreements, and procurement contracts from all federal awarding agencies that exceeds \$10,000,000 for any period of time during the period of performance of an award under this funding opportunity.

5. Monitoring and Oversight

Per 2 C.F.R. § 200.337, FEMA, through its authorized representatives, has the right, at all reasonable times, to make site visits or conduct desk reviews to review project accomplishments and management control systems to review award progress and to provide any required technical assistance. During site visits or desk reviews, FEMA will review recipients' files related to the award. As part of any monitoring and program evaluation activities, recipients must permit FEMA, upon reasonable notice, to review grant-related records and to interview the organization's staff and contractors regarding the program. Recipients must respond in a timely and accurate manner to FEMA requests for information relating to the award.

Effective monitoring and oversight help FEMA ensure that recipients use grant funds for their intended purpose(s); verify that projects undertaken are consistent with approved plans; and ensure that recipients make adequate progress toward stated goals and objectives. Additionally, monitoring serves as the primary mechanism to ensure that recipients comply with applicable laws, rules, regulations, program guidance, and requirements. FEMA regularly monitors all grant programs both financially and programmatically in accordance with federal laws, regulations (including 2 C.F.R. Part 200), program guidance, and the terms and conditions of the award. All monitoring efforts ultimately serve to evaluate progress towards grant goals and proactively target and address issues that may threaten grant success during the period of performance.

FEMA staff will periodically monitor recipients to ensure that administrative processes, policies and procedures, budgets, and other related award criteria are meeting Federal Government-wide and FEMA regulations. Aside from reviewing quarterly financial and programmatic reports, FEMA may also conduct enhanced monitoring through either desk-based reviews, onsite monitoring visits, or both. Enhanced monitoring will involve the review and analysis of the financial compliance and administrative processes, policies,

activities, and other attributes of each federal assistance award, and it will identify areas where the recipient may need technical assistance, corrective actions, or other support.

Financial and programmatic monitoring are complementary processes within FEMA's overarching monitoring strategy that function together to ensure effective grants management, accountability, and transparency; validate progress against grant and program goals; and safeguard federal funds against fraud, waste, and abuse. Financial monitoring primarily focuses on statutory and regulatory compliance with administrative grant requirements, while programmatic monitoring seeks to validate and assist in grant progress, targeting issues that may be hindering achievement of project goals and ensuring compliance with the purpose of the grant and grant program. Both monitoring processes are similar in that they feature initial reviews of all open awards, and additional, in-depth monitoring of grants requiring additional attention.

Recipients and subrecipients who are pass-through entities are responsible for monitoring their subrecipients in a manner consistent with the terms of the federal award at 2 C.F.R. Part 200, including 2 C.F.R. § 200.332. This includes the pass-through entity's responsibility to monitor the activities of the subrecipient as necessary to ensure that the subaward is used for authorized purposes, in compliance with federal statutes, regulations, and the terms and conditions of the subaward; and that subaward performance goals are achieved.

In terms of overall award management, recipient and subrecipient responsibilities include, but are not limited to: accounting of receipts and expenditures, cash management, maintaining adequate financial records, reporting and refunding expenditures disallowed by audits, monitoring if acting as a pass-through entity, or other assessments and reviews, and ensuring overall compliance with the terms and conditions of the award or subaward, as applicable, including the terms of 2 C.F.R. H. Additional Information

1. Termination Provisions

FEMA may terminate a federal award in whole or in part for one of the following reasons. FEMA and the recipient must still comply with closeout requirements at 2 C.F.R. §§ 200.344-200.345 even if an award is terminated in whole or in part. To the extent that subawards are permitted under this NOFO, pass-through entities should refer to 2 C.F.R. § 200.340 for additional information on termination regarding subawards.

a. Noncompliance

If a recipient fails to comply with the terms and conditions of a federal award, FEMA may terminate the award in whole or in part. If the noncompliance can be corrected, FEMA may first attempt to direct the recipient to correct the noncompliance. This may take the form of a Compliance Notification. If the noncompliance cannot be corrected or the recipient is non-responsive, FEMA may proceed with a Remedy Notification, which could impose a remedy for noncompliance per 2 C.F.R. § 200.339, including termination. Any action to terminate based on noncompliance will follow the requirements of 2 C.F.R. §§ 200.341-200.342 as well as the requirement of 2 C.F.R. § 200.340(c) to report in FAPIIS the recipient's material failure to comply with the award terms and conditions. b. With the Consent of the Recipient

FEMA may also terminate an award in whole or in part with the consent of the recipient, in which case the parties must agree upon the termination conditions, including the effective date, and in the case of partial termination, the portion to be terminated.

c. Notification by the Recipient

The recipient may terminate the award, in whole or in part, by sending written notification to FEMA setting forth the reasons for such termination, the effective date, and in the case of partial termination, the portion to be terminated. In the case of partial termination, FEMA may determine that a partially terminated award will not accomplish the purpose of the federal award, so FEMA may terminate the award in its entirety. If that occurs, FEMA will follow the requirements of 2 C.F.R. §§ 200.341-200.342 in deciding to fully terminate the award.

2. Period of Performance Extensions

Extensions to the period of performance (POP) for this program are allowed. Extensions to the POP identified in the award will only be considered through formal, written requests to the recipient's FEMA Program Analyst and must contain specific and compelling justifications as to why an extension is required. Recipients are advised to coordinate with the FEMA Program Analyst as needed when preparing an extension request.

All extension requests must address the following:

a. The grant program, fiscal year, and award number;

- b. Reason for the delay –including details of the legal, policy, or operational challenges that prevent the final outlay of awarded funds by the deadline;
- c. Current status of the activity(ies);
- d. Approved POP termination date and new project completion date;
- e. Amount of funds drawn down to date;
- f. Remaining available funds, both federal and, if applicable, non-federal;
- g. Budget outlining how remaining federal and, if applicable, non-federal funds will be expended;
- h. Plan for completion, including milestones and timeframes for achieving each milestone and the position or person responsible for implementing the plan for completion; and
- i. Certification that the activity(ies) will be completed within the extended POP without any modification to the original statement of work, as described in the application or other relevant document and as approved by FEMA.

Extension requests will be granted only due to compelling legal, policy, or operational challenges. Extension requests will only be considered for the following reasons:

- Contractual commitments by the recipient or subrecipient with vendors prevent completion of the project, including delivery of equipment or services, within the existing POP;
- The project must undergo a complex environmental review that cannot be completed within the existing POP;
- Projects are long-term by design, and therefore acceleration would compromise core programmatic goals; or
- Where other special or extenuating circumstances exist.

Recipients should submit all proposed extension requests to FEMA for review and approval at least 90 days prior to the end of the POP to allow sufficient processing time. Extensions are typically granted for no more than a six-month period.

3. Disability Integration

Pursuant to Section 504 of the Rehabilitation Act of 1973, recipients of FEMA financial assistance must ensure that their programs and activities do not discriminate against other qualified individuals with disabilities.

Grant recipients should engage with the whole community to advance individual and community preparedness and to work as a nation to build and sustain resilience. In doing so, recipients are encouraged to consider the needs of individuals with disabilities into the activities and projects funded by the grant.

FEMA expects that the integration of the needs of people with disabilities will occur at all levels, including planning; alerting, notification, and public outreach; training; purchasing of equipment and supplies; protective action implementation; and exercises/drills.

The following are examples that demonstrate the integration of the needs of people with disabilities in carrying out FEMA awards:

- Include representatives of organizations that work with/for people with disabilities on planning committees, work groups and other bodies engaged in development and implementation of the grant programs and activities.
- Hold all activities related to the grant in locations that are accessible to persons with physical disabilities to the extent practicable.
- Acquire language translation services, including American Sign Language, that provide public information across the community and in shelters.
- Ensure shelter-specific grant funds are in alignment with FEMA's <u>Guidance on</u>
 <u>Planning for Integration of Functional Needs Support Services in General Population</u>
 Shelters.
- If making alterations to an existing building to a primary function area utilizing federal funds, complying with the most recent codes and standards and making path of travel to the primary function area accessible to the greatest extent possible.
- Implement specific procedures used by public transportation agencies that include evacuation and passenger communication plans and measures for individuals with disabilities.
- Identify, create, and deliver training to address any training gaps specifically aimed toward whole-community preparedness. Include and interact with individuals with disabilities, aligning with the designated program capability.
- Establish best practices in inclusive planning and preparedness that consider physical access, language access, and information access. Examples of effective communication access include providing auxiliary aids and services such as sign language interpreters, Computer Aided Real-time Translation (CART), and materials in Braille or alternate formats.

FEMA grant recipients can fund projects towards the resiliency of the whole community, including people with disabilities, such as training, outreach and safety campaigns, provided that the project aligns with this NOFO and the terms and conditions of the award.

4. Conflicts of Interest in the Administration of Federal Awards or Subawards For conflicts of interest under grant-funded procurements and contracts, refer to the section on Procurement Integrity in this NOFO and 2 C.F.R. §§ 200.317 – 200.327.

To eliminate and reduce the impact of conflicts of interest in the subaward process, recipients and pass-through entities must follow their own policies and procedures regarding the elimination or reduction of conflicts of interest when making subawards. Recipients and pass-through entities are also required to follow any applicable federal and state, local, tribal, or territorial (SLTT) statutes or regulations governing conflicts of interest in the making of subawards.

The recipient or pass-through entity must disclose to the respective Program Analyst or Program Manager, in writing, any real or potential conflict of interest that may arise during the administration of the federal award, as defined by the federal or SLTT statutes or regulations or their own existing policies, within five days of learning of the conflict of interest. Similarly, subrecipients, whether acting as subrecipients or as pass-through entities, must disclose any real or potential conflict of interest to the recipient or next-level pass-

through entity as required by the recipient or pass-through entity's conflict of interest policies, or any applicable federal or SLTT statutes or regulations.

Conflicts of interest may arise during the process of FEMA making a federal award in situations where an employee, officer, or agent, any members of his or her immediate family, his or her partner has a close personal relationship, a business relationship, or a professional relationship, with an applicant, subapplicant, recipient, subrecipient, or FEMA employees.

5. Procurement Integrity

Through audits conducted by the DHS Office of Inspector General (OIG) and FEMA grant monitoring, findings have shown that some FEMA recipients have not fully adhered to the proper procurement requirements when spending grant funds. Anything less than full compliance with federal procurement requirements jeopardizes the integrity of the grant as well as the grant program. To assist with determining whether an action is a procurement or instead a subaward, please consult 2 C.F.R. § 200.331.

The below highlights the federal procurement requirements for FEMA recipients when procuring goods and services with federal grant funds. FEMA will include a review of recipients' procurement practices as part of the normal monitoring activities. All procurement activity must be conducted in accordance with federal procurement standards at 2 C.F.R. §§ 200.317 – 200.327. Select requirements under these standards are listed below. The recipient and any of its subrecipients must comply with all requirements, even if they are not listed below.

Under 2 C.F.R. § 200.317, when procuring property and services under a federal award, states (including territories) must follow the same policies and procedures they use for procurements from their non-federal funds; additionally, states must now follow 2 C.F.R. § 200.321 regarding socioeconomic steps, 200.322 regarding domestic preferences for procurements, 200.323 regarding procurement of recovered materials, and 2 C.F.R. § 200.327 regarding required contract provisions.

All other non-federal entities, such as tribes (collectively, non-state entities), must have and use their own documented procurement procedures that reflect applicable SLTT laws and regulations, provided that the procurements conform to applicable federal law and the standards identified in 2 C.F.R. Part 200. These standards include, but are not limited to, providing for full and open competition consistent with the standards of 2 C.F.R. § 200.319 and § 200.320.

a. Important Changes to Procurement Standards in 2 C.F.R. Part 200

OMB recently updated various parts of Title 2 of the Code of Federal Regulations, among them, the procurement standards. States are now required to follow the socioeconomic steps in soliciting small and minority businesses, women's business enterprises, and labor surplus area firms per 2 C.F.R. § 200.321. All non-federal entities should also, to the greatest extent practicable under a federal award, provide a preference for the purchase, acquisition, or use of goods, products, or materials produced in the United States per 2 C.F.R. § 200.322.

The recognized procurement methods in 2 C.F.R. § 200.320 have been reorganized into informal procurement methods, which include micro-purchases and small purchases; formal procurement methods, which include sealed bidding and competitive proposals; and noncompetitive procurements. The federal micro-purchase threshold is currently \$10,000, and non-state entities may use a lower threshold when using micro-purchase procedures under a FEMA award. If a non-state entity wants to use a micro-purchase threshold higher than the federal threshold, it must follow the requirements of 2 C.F.R. § 200.320(a)(1)(iii)-(iv). The federal simplified acquisition threshold is currently \$250,000, and a non-state entity may use a lower threshold but may not exceed the federal threshold when using small purchase procedures under a FEMA award.

See 2 C.F.R. §§ 200.216, 200.471, and Appendix II as well as section D.13.a of the NOFO regarding prohibitions on covered telecommunications equipment or services.

b. Competition and Conflicts of Interest

Among the requirements of 2 C.F.R. § 200.319(b) applicable to all non-federal entities other than states, in order to ensure objective contractor performance and eliminate unfair competitive advantage, contractors that develop or draft specifications, requirements, statements of work, or invitations for bids or requests for proposals must be excluded from competing for such procurements. FEMA considers these actions to be an organizational conflict of interest and interprets this restriction as applying to contractors that help a non-federal entity develop its grant application, project plans, or project budget. This prohibition also applies to the use of former employees to manage the grant or carry out a contract when those former employees worked on such activities while they were employees of the non-federal entity.

Under this prohibition, unless the non-federal entity solicits for and awards a contract covering both development <u>and</u> execution of specifications (or similar elements as described above), and this contract was procured in compliance with 2 C.F.R. §§ 200.317 – 200.327, federal funds cannot be used to pay a contractor to carry out the work if that contractor also worked on the development of those specifications. This rule applies to all contracts funded with federal grant funds, including pre-award costs, such as grant writer fees, as well as post-award costs, such as grant management fees.

Additionally, some of the situations considered to be restrictive of competition include, but are not limited to:

- Placing unreasonable requirements on firms for them to qualify to do business;
- Requiring unnecessary experience and excessive bonding;
- Noncompetitive pricing practices between firms or between affiliated companies;
- Noncompetitive contracts to consultants that are on retainer contracts;
- Organizational conflicts of interest;
- Specifying only a "brand name" product instead of allowing "an equal" product to be offered and describing the performance or other relevant requirements of the procurement; and
- Any arbitrary action in the procurement process.

Per 2 C.F.R. § 200.319(c), non-federal entities other than states must conduct procurements in a manner that prohibits the use of statutorily or administratively imposed SLTT geographical preferences in the evaluation of bids or proposals, except in those cases where applicable federal statutes expressly mandate or encourage geographic preference. Nothing in this section preempts state licensing laws. When contracting for architectural and engineering services, geographic location may be a selection criterion provided its application leaves an appropriate number of qualified firms, given the nature and size of the project, to compete for the contract.

Under 2 C.F.R. § 200.318(c)(1), non-federal entities other than states are required to maintain written standards of conduct covering conflicts of interest and governing the actions of their employees engaged in the selection, award, and administration of contracts. No employee, officer, or agent may participate in the selection, award, or administration of a contract supported by a federal award if he or she has a real or apparent conflict of interest. Such conflicts of interest would arise when the employee, officer or agent, any member of his or her immediate family, his or her partner, or an organization that employs or is about to employ any of the parties indicated herein, has a financial or other interest in or a tangible personal benefit from a firm considered for a contract.

The officers, employees, and agents of the non-federal entity may neither solicit nor accept gratuities, favors, or anything of monetary value from contractors or parties to subcontracts. However, non-federal entities may set standards for situations in which the financial interest is not substantial, or the gift is an unsolicited item of nominal value. The standards of conduct must provide for disciplinary actions to be applied for violations of such standards by officers, employees, or agents of the non-federal entity. If the recipient or subrecipient (other than states) has a parent, affiliate, or subsidiary organization that is not a state, local, tribal, or territorial government, the non-federal entity must also maintain written standards of conduct covering organizational conflicts of interest. In this context, organizational conflict of interest means that because of a relationship with a parent company, affiliate, or subsidiary organization, the non-federal entity is unable or appears to be unable to be impartial in conducting a procurement action involving a related organization. The non-federal entity must disclose in writing any potential conflicts of interest to FEMA or the pass-through entity in accordance with applicable FEMA policy.

c. Supply Schedules and Purchasing Programs

Generally, a non-federal entity may seek to procure goods or services from a federal supply schedule, state supply schedule, or group purchasing agreement.

I. GENERAL SERVICES ADMINISTRATION SCHEDULES

States, tribes, and local governments, and any instrumentality thereof (such as local education agencies or institutions of higher education) may procure goods and services from a General Services Administration (GSA) schedule. GSA offers multiple efficient and effective procurement programs for state, tribal, and local governments, and instrumentalities thereof, to purchase products and services directly from pre-vetted contractors. The GSA Schedules (also referred to as the Multiple Award Schedules and the Federal Supply

Schedules) are long-term government-wide contracts with commercial firms that provide access to millions of commercial products and services at volume discount pricing.

Information about GSA programs for states, tribes, and local governments, and instrumentalities thereof, can be found at https://www.gsa.gov/resources-for/programs-for-State-and-local-governments and https://www.gsa.gov/buying-selling/purchasing-programs/gsa-schedules/schedule-buyers/state-and-local-governments.

For tribes, local governments, and their instrumentalities that purchase off of a GSA schedule, this will satisfy the federal requirements for full and open competition provided that the recipient follows the GSA ordering procedures; however, tribes, local governments, and their instrumentalities will still need to follow the other rules under 2 C.F.R. §§ 200.317 – 200.327, such as solicitation of minority businesses, women's business enterprises, small businesses, or labor surplus area firms (§ 200.321), domestic preferences (§ 200.322), contract cost and price (§ 200.324), and required contract provisions (§ 200.327 and Appendix II).

II. OTHER SUPPLY SCHEDULES AND PROGRAMS

For non-federal entities other than states, such as tribes, local governments, and nonprofits, that want to procure goods or services from a state supply schedule, cooperative purchasing program, or other similar program, in order for such procurements to be permissible under federal requirements, the following must be true:

- The procurement of the original contract or purchasing schedule and its use by the non-federal entity complies with state and local law, regulations, and written procurement procedures;
- The state or other entity that originally procured the original contract or purchasing schedule entered into the contract or schedule with the express purpose of making it available to the non-federal entity and other similar types of entities;
- The contract or purchasing schedule specifically allows for such use, and the work to be performed for the non-federal entity falls within the scope of work under the contract as to type, amount, and geography;
- The procurement of the original contract or purchasing schedule complied with all the procurement standards applicable to a non-federal entity other than states under at 2 C.F.R. §§ 200.317 200.327; and
- With respect to the use of a purchasing schedule, the non-federal entity must follow ordering procedures that adhere to applicable state, tribal, and local laws and regulations and the minimum requirements of full and open competition under 2 C.F.R. Part 200.

If a non-federal entity other than a state seeks to use a state supply schedule, cooperative purchasing program, or other similar type of arrangement, FEMA recommends the recipient discuss the procurement plans with its FEMA Program Analyst.

d. Procurement Documentation

Per 2 C.F.R. § 200.318(i), non-federal entities other than states and territories are required to maintain and retain records sufficient to detail the history of procurement covering at least

the rationale for the procurement method, contract type, contractor selection or rejection, and the basis for the contract price. States and territories are encouraged to maintain and retain this information as well and are reminded that in order for any cost to be allowable, it must be adequately documented per 2 C.F.R. § 200.403(g).

Examples of the types of documents that would cover this information include but are not limited to:

- Solicitation documentation, such as requests for quotes, invitations for bids, or requests for proposals;
- Responses to solicitations, such as quotes, bids, or proposals;
- Pre-solicitation independent cost estimates and post-solicitation cost/price analyses on file for review by federal personnel, if applicable;
- Contract documents and amendments, including required contract provisions; and
- Other documents required by federal regulations applicable at the time a grant is awarded to a recipient.

6. Record Retention

a. Record Retention Period

Financial records, supporting documents, statistical records, and all other non-federal entity records pertinent to a federal award generally must be maintained for <u>at least</u> three years from the date the final FFR is submitted. *See* 2 C.F.R. § 200.334. Further, if the recipient does not submit a final FFR and the award is administratively closed, FEMA uses the date of administrative closeout as the start of the general record retention period.

The record retention period may be longer than three years or have a different start date in certain cases. These include:

- Records for real property and equipment acquired with federal funds must be retained for three years after final disposition of the property. See 2 C.F.R. § 200.334(c).
- If any litigation, claim, or audit is started before the expiration of the three-year period, the records **must be retained until** all litigation, claims, or audit findings involving the records **have been resolved and final action taken**. See 2 C.F.R. § 200.334(a).
- The record retention period will be extended if the recipient is notified in writing of the extension by FEMA, the cognizant or oversight agency for audit, or the cognizant agency for indirect costs. See 2 C.F.R. § 200.334(b).
- Where FEMA requires recipients to report program income after the period of performance ends, the **program income record retention period begins at the end of the recipient's fiscal year in which program income is earned**. See 2 C.F.R. § 200.334(e).
- For indirect cost rate proposals, cost allocation plans, or other rate computations records, the start of the record retention period depends on whether the indirect cost rate documents were submitted for negotiation. If the indirect cost rate documents were submitted for negotiation, the record retention period begins from the date those documents were submitted for negotiation. If indirect cost rate documents were not submitted for negotiation, the record retention period begins at the end

of the recipient's fiscal year or other accounting period covered by that indirect cost rate. See 2 C.F.R. § 200.334(f).

b. Types of Records to Retain

FEMA requires that non-federal entities maintain the following documentation for federally funded purchases:

- Specifications
- Solicitations
- Competitive quotes or proposals
- Basis for selection decisions
- Purchase orders
- Contracts
- Invoices
- Cancelled checks

Non-federal entities should keep detailed records of all transactions involving the grant. FEMA may at any time request copies of any relevant documentation and records, including purchasing documentation along with copies of cancelled checks for verification. *See, e.g.*, 2 C.F.R. §§ 200.318(i), 200.334, 200.337.

In order for any cost to be allowable, it must be adequately documented per 2 C.F.R. § 200.403(g). Non-federal entities who fail to fully document all purchases may find their expenditures questioned and subsequently disallowed.

7. Actions to Address Noncompliance

Non-federal entities receiving financial assistance funding from FEMA are required to comply with requirements in the terms and conditions of their awards or subawards, including the terms set forth in applicable federal statutes, regulations, NOFOs, and policies. Throughout the award lifecycle or even after an award has been closed, FEMA or the pass-through entity may discover potential or actual noncompliance on the part of a recipient or subrecipient. This potential or actual noncompliance may be discovered through routine monitoring, audits, closeout, or reporting from various sources.

In the case of any potential or actual noncompliance, FEMA may place special conditions on an award per 2 C.F.R. §§ 200.208 and 200.339, FEMA may place a hold on funds until the matter is corrected, or additional information is provided per 2 C.F.R. § 200.339, or it may do both. Similar remedies for noncompliance with certain federal civil rights laws are authorized pursuant to 44 C.F.R. Parts 7 and 19.

In the event the noncompliance is not able to be corrected by imposing additional conditions or the recipient or subrecipient refuses to correct the matter, FEMA might take other remedies allowed under 2 C.F.R. § 200.339. These remedies include actions to disallow costs, recover funds, wholly or partly suspend or terminate the award, initiate suspension and debarment proceedings, withhold further federal awards, or take other remedies that may be legally available. For further information on termination due to noncompliance, see the section on Termination Provisions in the NOFO.

FEMA may discover and take action on noncompliance even after an award has been closed. The closeout of an award does not affect FEMA's right to disallow costs and recover funds as long the action to disallow costs takes place during the record retention period. *See* 2 C.F.R. §§ 200.334, 200.345(a). Closeout also does not affect the obligation of the non-federal entity to return any funds due as a result of later refunds, corrections, or other transactions. 2 C.F.R. § 200.345(a)(2).

The types of funds FEMA might attempt to recover include, but are not limited to, improper payments, cost share reimbursements, program income, interest earned on advance payments, or equipment disposition amounts.

FEMA may seek to recover disallowed costs through a Notice of Potential Debt Letter, a Remedy Notification, or other letter. The document will describe the potential amount owed, the reason why FEMA is recovering the funds, the recipient's appeal rights, how the amount can be paid, and the consequences for not appealing or paying the amount by the deadline.

If the recipient neither appeals nor pays the amount by the deadline, the amount owed will become final. Potential consequences if the debt is not paid in full or otherwise resolved by the deadline include the assessment of interest, administrative fees, and penalty charges; administratively offsetting the debt against other payable federal funds; and transferring the debt to the U.S. Department of the Treasury for collection.

FEMA notes the following common areas of noncompliance for FEMA's grant programs:

- Insufficient documentation and lack of record retention.
- Failure to follow the procurement under grants requirements.
- Failure to submit closeout documents in a timely manner.
- Failure to follow EHP requirements.
- Failure to comply with the POP deadline.

8. Audits

FEMA grant recipients are subject to audit oversight from multiple entities including the DHS OIG, the GAO, the pass-through entity, or independent auditing firms for single audits, and may cover activities and costs incurred under the award. Auditing agencies such as the DHS OIG, the GAO, and the pass-through entity (if applicable), and FEMA in its oversight capacity, must have access to records pertaining to the FEMA award. Recipients and subrecipients must retain award documents for at least three years from the date the final FFR is submitted, and even longer in many cases subject to the requirements of 2 C.F.R. § 200.334. In the case of administrative closeout, documents must be retained for at least three years from the date of closeout, or longer subject to the requirements of 2 C.F.R. § 200.334. If documents are retained longer than the required retention period, the DHS OIG, the GAO, and the pass-through entity, as well as FEMA in its oversight capacity, have the right to access these records as well. *See* 2 C.F.R. §§ 200.334, 200.337.

Additionally, non-federal entities must comply with the single audit requirements at 2 C.F.R. Part 200, Subpart F. Specifically, non-federal entities, other than for-profit subrecipients, that expend \$750,000 or more in federal awards during their fiscal year must have a single or

program-specific audit conducted for that year in accordance with Subpart F. 2 C.F.R. § 200.501. A single audit covers all federal funds expended during a fiscal year, not just FEMA funds. The cost of audit services may be allowable per 2 C.F.R. § 200.425, but non-federal entities must select auditors in accordance with 2 C.F.R. § 200.509, including following the proper procurement procedures. For additional information on single audit reporting requirements, see section F of this NOFO under the header "Single Audit Report" within the subsection "Additional Reporting Requirements" or other applicable document.

The objectives of single audits are to:

- Determine if financial statements conform to generally accepted accounting principles (GAAP);
- Determine whether the schedule of expenditures of federal awards is presented fairly;
- Understand, assess, and test the adequacy of internal controls for compliance with major programs; and
- Determine if the entity complied with applicable laws, regulations, and contracts or grants.

For single audits, the auditee is required to prepare financial statements reflecting its financial position, a schedule of federal award expenditures, and a summary of the status of prior audit findings and questioned costs. The auditee also is required to follow up and take appropriate corrective actions on new and previously issued but not yet addressed audit findings. The auditee must prepare a corrective action plan to address the new audit findings. 2 C.F.R. §§ 200.508, 200.510, 200.511.

Non-federal entities must have an audit conducted, either single or program-specific, of their financial statements and federal expenditures annually or biennially pursuant to 2 C.F.R. § 200.504. Non-federal entities must also follow the information submission requirements of 2 C.F.R. § 200.512, including submitting the audit information to the <u>Federal Audit Clearinghouse</u> within the earlier of 30 calendar days after receipt of the auditor's report(s) or nine months after the end of the audit period. The audit information to be submitted include the data collection form described at 2 C.F.R. § 200.512(c) and Appendix X to 2 C.F.R. Part 200 as well as the reporting package described at 2 C.F.R. § 200.512(b).

The non-federal entity must retain one copy of the data collection form and one copy of the reporting package for three years from the date of submission to the Federal Audit Clearinghouse. 2 C.F.R. § 200.512; see also 2 C.F.R. § 200.517 (setting requirements for retention of documents by the auditor and access to audit records in the auditor's possession).

FEMA, the DHS OIG, the GAO, and the pass-through entity (if applicable), as part of monitoring or as part of an audit, may review a non-federal entity's compliance with the single audit requirements. In cases of continued inability or unwillingness to have an audit conducted in compliance with 2 C.F.R. Part 200, Subpart F, FEMA and the pass-through entity, if applicable, are required to take appropriate remedial action under 2 C.F.R. § 200.339 for noncompliance, pursuant to 2 C.F.R. § 200.505.

9. Payment Information

FEMA uses the Direct Deposit/Electronic Funds Transfer (DD/EFT) method of payment to recipients. To enroll in the DD/EFT, the recipient must complete SF-1199A, Direct Deposit Form.

FEMA utilizes the Payment and Reporting System (PARS) for financial reporting, invoicing and tracking payments. For additional information, refer to https://isource.fema.gov/sf269/execute/LogIn?sawContentMessage=true.

10. Whole Community Preparedness

Preparedness is a shared responsibility that calls for the involvement of everyone—not just the government—in preparedness efforts. By working together, everyone can help keep the nation safe from harm and help keep it resilient when struck by hazards, such as natural disasters, acts of terrorism, and pandemics.

Whole Community includes:

- Individuals and families, including those with access and functional needs
- Businesses
- Faith-based and community organizations
- Nonprofit groups
- Schools and academia
- Media outlets
- All levels of government, including state, local, tribal, territorial, and federal partners

The phrase "Whole Community" often appears in preparedness materials, as it is one of the guiding principles. It means two things:

- 1. Involving people in the development of national preparedness documents.
- 2. Ensuring their roles and responsibilities are reflected in the content of the materials.

11. Appendices

Any assessment processes supported by the EMBAG must include a review of the following sixteen (16) areas within an emergency management program as part of their assessment and accreditation process:

- 1. Emergency Management Program Administration, including Authorities, Oversight, and Strategic Planning;
- 2. Development and use of a THIRA;
- 3. Continuity of Government and Continuity of Operations;
- 4. Incident Management, to include NIMS and NQS Implementation;
- 5. Emergency Management Finance, including Disaster Cost Recovery;
- 6. Operations and Procedures;
- 7. Consequence Analysis;
- 8. Emergency Planning, including Mutual Aid, Communications, and Warning;
- 9. Evacuation and Shelter in Place;
- 10. Mass Care and Sheltering;
- 11. Resource Management and Logistics;
- 12. Recovery;
- 13. Disaster Housing;
- 14. Hazard Mitigation;
- 15. Training and Exercises, including Alignment with the Homeland Security Exercise and Evaluation Program (HSEEP); and
- 16. Public Affairs.

Any standards supported by the EMBAG should align to the nine (9) FEMA guidance resources outlined below:

1. National Preparedness System (NPS)

The NPS serves as the instrument the Nation employs to build, sustain, and deliver core capabilities in order to achieve the <u>National Preparedness Goal</u> (the Goal) of "a secure and resilient Nation with the capabilities required across the whole community to prevent, protect against, mitigate, respond to, and recover from the threats and hazards that pose the greatest risk." The Goal defines resilience as the ability to adapt to changing conditions and withstand and rapidly recover from disruption due to emergencies.

2. National Continuity Policy

CPG 201, Third Edition includes both the THIRA and SPR because they are interconnected processes that, together, communities use to evaluate their preparedness. All types of communities can complete the THIRA/SPR as a way to better understand the risks they face and make important decisions on how to prevent, protect against, mitigate, respond to, and recover from the threats and hazards that pose the greatest risks.

For the purposes of SHSP and UASI, FEMA requires states, territories, and Urban Areas to complete a THIRA and Stakeholder Preparedness Review (SPR) (formerly known as the State Preparedness Report) and prioritize grant funding to support closing capability gaps or sustaining capabilities identified in this process. 8. National Response Framework, fourth edition and Community Lifelines

The National Response Framework, fourth edition, provides foundational emergency management doctrine for how the Nation responds to all types of incidents. The NRF is built on scalable, flexible, and adaptable concepts identified in the National Incident Management System (NIMS) to align key roles and responsibilities across the Nation. The structures, roles, and responsibilities described in this Framework can be partially or fully implemented in the context of a threat or hazard, in anticipation of a significant event, or in response to an incident. Implementation of the structures and procedures described herein allows for a scaled response, delivery of specific resources and capabilities, and a level of coordination appropriate to each incident.

Community Lifelines are a tool that allows for decision makers across the nation to rapidly determine whether an incident is large or complex; prioritize and focus response efforts to maintain or restore the most critical services and infrastructure; ensure limited resources can go toward a common goal that requires involvement across the whole community; and promote a response that fosters better integration and communication through management that transcends public and private sector boundaries. 9. Homeland Security Exercise and Evaluation Program (HSEEP)

Exercises are a key component of national preparedness — they provide the whole community with the opportunity to shape planning, assess and validate capabilities, and address areas for improvement. HSEEP provides a set of guiding principles for exercise and evaluation programs, as well as a common approach to exercise program management, design and development, conduct, evaluation, and improvement planning. Through the use of HSEEP, the whole community can develop, execute, and evaluate exercises that address the preparedness priorities. These priorities are informed by risk and capability assessments, findings, corrective actions from previous events, and external requirements. These priorities guide the overall direction of an exercise program and the design and development of individual exercises.

Appendix B: Detail on EMBAG Performance Measurement

The performance of the EMBAG is measured against the intended outcomes identified in the Objectives section of this NOFO. Short to mid-term outcomes consist of achieving compliance with national level standards for critical functions necessary to prepare for and manage disasters or to manage emergency management programs. Long-term outcomes consist of increasing preparedness to manage disasters or increasing capability to manage emergency management programs during disasters. The performance of the EMBAG in achieving its targeted short and mid-term outcomes is measured through Metrics 1 and 2 below and the performance of the EMBAG in achieving its targeted long-term outcome can be measured in part through Metrics 3 and 4 below.

All projects and activities under the two objectives listed in the Objectives section contribute to these outcomes. These projects either contribute systemically, through the support of the national-level standards in terms of governance, revising standards, or developing training and planning needed for conducting assessments, or directly, in terms of training and assessments targeted to emergency management programs and professionals to help them obtain accreditation or certification according to the national-level standards for emergency management. FEMA may use data collected from EMBAG performance measures to study improvements in national capability according to other data sources.

Applicants must describe in their application how they will collect data on FY 2021 EMBAG Performance Metrics relevant to their application. Applicants must include a description of how they are collecting and storing raw data used to calculate scores for these metrics and what methods they are using to calculate metrics. - Efforts should include developing, maintaining, updating, and improving systems, policy, and processes necessary to complete the objectives of the EMBAG.

- Collecting input from the emergency management community, including subject matter experts (SMEs) and practitioners from multiple emergency management disciplines regarding multiple hazard and jurisdiction types.
- Reviewing and synthesizing input and provide the results of this

<u>Objective 2, Project 5</u>: Conduct assessments on a volunteer basis for state, local, tribal, and territorial emergency management professionals against these standards and criteria.

Appendix H: Guidance for Data Collection and Continuity Assessment Tool Activities

This appendix contains additional guidance for Data Collection and Continuity Assessment Tool (CAT) Assessments, which are example activities that meet requirements under Objective 1, Project 3. Applicants that incorporate these tasks into their application must describe how they will carry them out under the Project Plan section of their Project Narrative to receive a satisfactory score for the Project Plan section of the EMBAG Evaluation and Scoring Criteria as described in Appendix D: Project Narrative Template and Appendix E: Evaluation and Scoring Criteria. The guidance in this appendix is an extension of the post-award workplan requirements described in Appendix G: Post-Award Requirements that recipients must incorporate into their final workplan, if they or their partner will implement Data Collection or CAT assessments.

- <u>For Data Collection Assessments</u>: The recipient must provide FEMA a final report for each of the following tasks (I-V) that covers all assessments conducted as part of the data collection forms described in <u>Appendix G: Post-Award Requirements</u> of this NOFO.
 - The recipient will coordinate with relevant FEMA programs through FEMA to develop data collection forms with specific language and guidance materials no later than 30 days after the award kickoff meeting for the grant, which will take place no more than 70 days after the FY 2021 EMBAG grant award date.
 - The recipient will conduct these tasks for at least 10 jurisdiction program on-site assessments supported by the FY 2021 EMBAG.
 - The recipient must include the name, publication date, and section of the jurisdiction plan (Tasks I, III, IV, and V) or resource management system (Task II) used to answer the questions in the data collection form.
 - If a jurisdiction is required to submit a THIRA/SPR, the recipient is encouraged to consider a jurisdiction's THIRA to inform its review for Tasks I-III and must consider a jurisdictions THIRA for Task IV, if applicable.

I. Task I - Continuity Plans:

The recipient should review jurisdiction Continuity Plans during each jurisdiction on-site assessment for alignment to the <u>2018 Continuity Guidance Circular</u> for all questions in this task's data collection form to ensure that a jurisdiction can perform its essential functions and provide critical services.

Questions in this task's data collection form will apply to jurisdiction Continuity of Operations and Continuity of Government plans. Terminology and phrasing in the data collection form should align to the 2018 Continuity Guidance Circular.

II. Task II - Resource Management Systems:

The recipient should review jurisdiction qualification, certification, and credentialing processes and programs during each jurisdiction on-site assessment for alignment to the NIMS Guideline to the National Qualification System for all questions in this task's data collection form, specifically as applicable to an incident workforce.

Note: Members of an incident workforce are individuals and teams that work in any NIMS incident capacity.

Questions in this task's data collection form will apply to jurisdiction qualification, certification, and credentialing processes. Terminology and phrasing in the data collection form should align to the <u>NIMS Guideline to the National Qualification System</u>.

III. Task III - Emergency Operations Plans and Recovery Plans:

For all questions in this task's data collection form, the recipient should review jurisdiction Emergency Operations Plans (EOPs) and Recovery Plans during each jurisdiction on-site assessment for alignment to the NDRF Second Edition (June 2016) and FEMA's Pre-Disaster Recovery Planning Guides (Pre-Disaster Recovery Planning Guide for States (November 2016), Pre-Disaster Recovery Planning Guide for Tribal Governments (September 2019), and the Pre-Disaster Recovery Planning Guide for Local Governments (February 2017)). For disaster cost recovery related questions, the recipient should review jurisdiction Emergency Operations Plans (EOPs) and Recovery Plans during each jurisdiction on-site assessment for alignment to the PAPPG, V4 (June 2020).

Questions in this task's data collection form will apply to jurisdiction EOPs and Recovery Plans. Terminology and phrasing in the data collection form should also align to the <u>NDRF Second Edition (June 2016)</u>, FEMA Pre-Disaster Recovery Planning Guides, and the <u>PAPPG, V4 (June 2020)</u>.

IV. Task IV - Threat and Hazard Identification and Risk Assessment:

If a jurisdiction is required to submit a THIRA and a SPR, the recipient should review the jurisdiction's latest submission during each jurisdiction on-site assessment for alignment to the Comprehensive Preparedness Guide (CPG) 201: Threat and Hazard Identification and Risk Assessment (THIRA) and Stakeholder Preparedness Review (SPR) Guide, Third Edition for all questions in this task's data collection form.

Questions in this task's data collection form will apply to jurisdiction hazard identification and risk assessments. Terminology and phrasing in the data collection form should align to the Comprehensive Preparedness Guide (CPG) 201: Threat and Hazard Identification and Risk Assessment (THIRA) and Stakeholder Preparedness Review (SPR) Guide, Third Edition.

<u>For CAT Assessments</u>: The recipient must also provide FEMA a final summary report as described in <u>Appendix G: Post-Award Requirements</u>.

V. Task V - Continuity Assessment Tool:

The recipient should review jurisdiction Continuity Plans and Programs for the Emergency Management Agencies and Office of the Governor using the Continuity Assessment Tool (CAT) as a baseline and methodology for the FEMA 2018-2022 Strategic Plan Objective 2.4, Improve Continuity and Resilient Communications Capabilities. Objective 2.4 includes the associated performance measure, "Increase the percentage of states and territories with comprehensive continuity plans and programs for state agencies and emergency operations centers that align with the Continuity Guidance Circular (CGC)" to ensure the continuation of their essential functions under all conditions.

FEMA and the recipient will coordinate to determine the six jurisdictions whom FEMA and the recipient propose to assess. Coordination with identified states will occur through the FEMA Regions. Upon agreement, the jurisdiction and the recipient will coordinate to identify mutually agreeable dates for the assessment. FEMA and the recipient will focus on the informational elements of the CAT.

This task will include:

- 1. Using the CAT as the baseline criteria for assessing whether a jurisdictional continuity plan and program aligns with the CGC.
- 2. Using the continuity assessment, either in coordination with or separate from a scheduled baseline assessment, with six states or territories by the end of the FY 2021 grant year.
- 3. Providing an annual summary report of findings to FEMA as described in <u>Appendix G:</u> <u>Post-Award Requirements</u>. The summary report will include:
 - a. CAT summary scores by CGC chapter; planning, organization, equipment, training, and exercise (POETE) solution area; and POETE solution area by CGC chapter;
 - b. Comprehensive continuity capability score, which represents the extent to which the jurisdiction's continuity plan and program aligns to the CGC; and
 - c. Overall areas of strength and areas for improvement to help guide future FEMA national continuity technical assistance, outreach, and development of resources.
- 4. Participating in in-person or virtual FEMA-led CGC and CAT training for assessment team members.
- 5. Allowing two FEMA staff members to observe the assessments to help inform knowledge of usefulness and effectiveness of the CAT and assessments.
