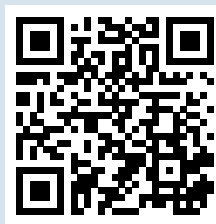

# FEMA Preparedness Grant Programs

### **Assistance to Firefighters Grant Programs**

Provides funds to fire departments, emergency medical services, other first responders, and non-profits to equip and train emergency personnel and support community resilience. Includes the **Assistance to Firefighters Grant (AFG)** program to fund equipment, gear, emergency vehicles, and training, the **Fire Prevention & Safety (FP&S)** program to improve firefighter safety and wellness, and the **Staffing for Adequate Fire & Emergency Response (SAFER)** program to fund “front line” firefighters.

### **Emergency Management Performance Grant (EMPG) Program**

Provides funding to state, local, tribal and territorial emergency management agencies for building and sustaining core capabilities.

### **Emergency Operations Center (EOC) Grant Program**

Provides funding to State Administrative Agencies and Tribal Governments for identified EOC projects to address deficiencies and ensure continuity of operations in major disasters or emergencies.

### **Homeland Security Grant Program (HSGP)**

Provides risk-based grants for state, local, tribal and territorial governments, and large metropolitan areas to protect against and respond to terrorist acts through the **State Homeland Security Program (SHSP)**. Also includes **Operation Stonegarden (OPSG)** to enhance cooperation among state, local, tribal, territorial, and federal

law enforcement to enhance security along U.S. borders, and **Urban Area Security Initiative (UASI)** to assist high-threat, high-density Urban Areas.

### **Intercity Bus Security Grant Program (IBSGP)**

Provides owners and operators of intercity bus systems with funds to protect critical infrastructure and the traveling public from terrorism and to increase transportation infrastructure resilience.

### **Intercity Passenger Rail (IPR)**

Provides funding for Amtrak to protect critical infrastructure and the traveling public from terrorism and to increase infrastructure resilience.

### **Nonprofit Security Grant Program (NSGP)**

Provides funding for nonprofits at high risk of terrorist attacks to improve their physical and cybersecurity. Grants include **NSGP-Urban Area** for nonprofits within a UASI-designated city and **NSGP-State** for nonprofits outside of UASI-designated areas.

### **Port Security Grant Program (PSGP)**

Provides funding to state, local and private-sector partners to protect critical infrastructure from terrorism and increase port resilience.

### **Presidential Residence Protection Assistance (PRPA) Grant Program**

Reimburses extraordinary state and local law enforcement or emergency personnel for operational overtime costs incurred from protecting the non-federal residences of the U.S. president.

### **Regional Catastrophic Preparedness Grant Program (RCPPG)**

Provides funding to state and local governments to close gaps in core capabilities and encourage innovative, regional solutions to threats of catastrophic incidents.

### **Shelter and Services Program (SSP)**

Provides funding to non-federal entities to provide shelter and other eligible services to non-citizens who have been encountered and released by the Department of Homeland Security.

### **State and Local Cybersecurity Grant Program (SLCGP) and the Tribal Cybersecurity Grant Program (TCGP)**

Provides funding to state, local, tribal, and territorial governments to manage and reduce systemic cyber risk for public agencies and tribal nations and to improve the resilience of the services they provide their community.

### **Transit Security Grant Program (TSGP)**

Provides funding to public transportation systems to protect critical infrastructure and the traveling public from terrorism and to increase transportation infrastructure resilience.

### **Tribal Homeland Security Grant Program (THSGP)**

Provides competitive funding to assist tribal governments into strengthening their capacities to prevent, prepare for, and respond to potential terrorist attacks.
