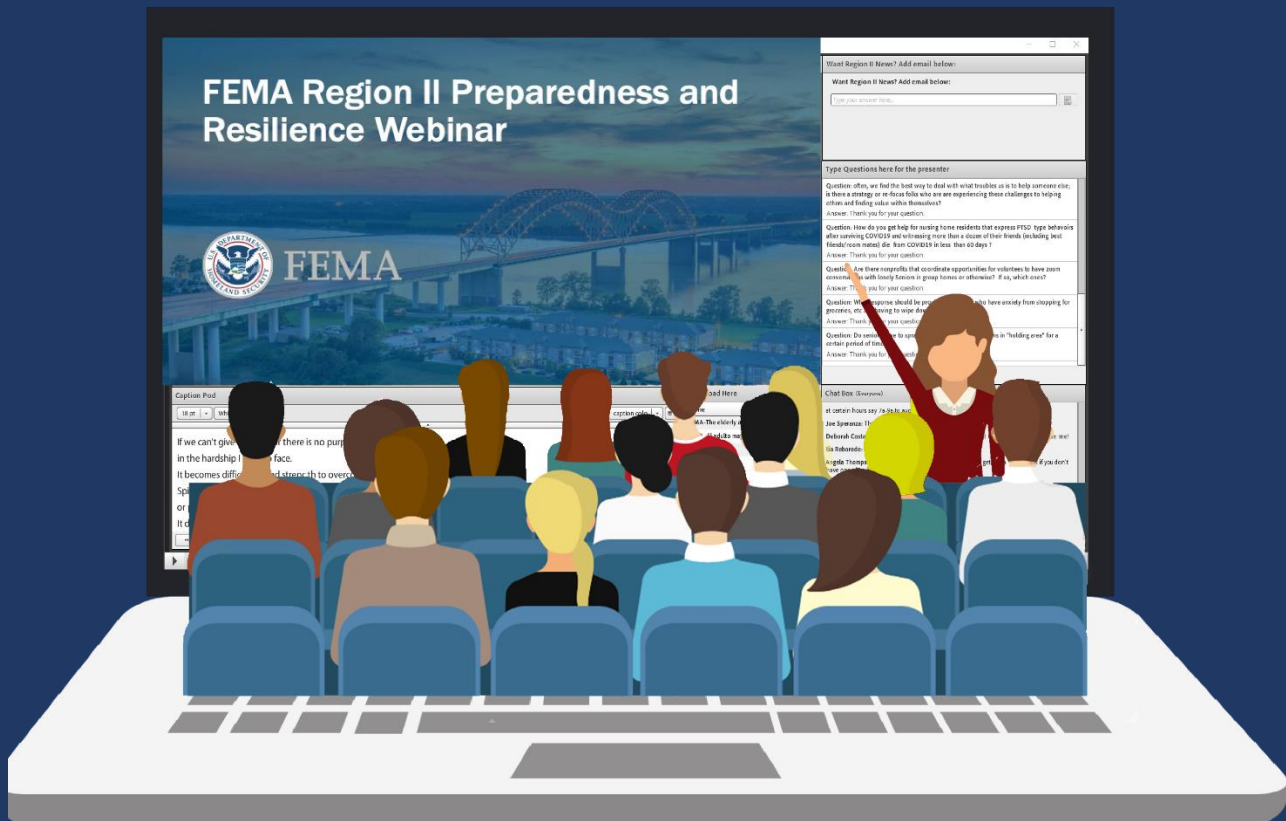

This session provides a brief overview of hurricane hazards, forecast products, and emergency management resources for hurricane planning and response.
26-Jun-24	Hurricane Preparedness for the Whole Community	This webinar will cover hurricane basics, information resources, and how to find out if you live in a hurricane evacuation zone. We will also discuss preparedness measures for people living in hurricane-prone areas, such as emergency supplies, insurance, preparing your home, and making an individual or family hurricane plan.
17-Jul-24	Pathway to Preparedness	The State of NJ, working in coordination with their Statewide Independent Living Council created this training with funding received from the Regional Catastrophic Preparedness Grant Program, New Jersey has been delivering this training to DAFN Communities throughout the State consisting of Independent Living Facilities, Senior Citizen Communities, and many others. An abridged version of the training will be delivered followed by a 30-minute session with tips on how you can deliver this program in your community.

24-Jul-24	How to Create Accessible Documents	Do you know why Digital Accessibility is important? If Microsoft Office products like Word, PowerPoint, Excel, and Outlook along with Adobe Acrobat PDF documents cannot be read and understood by everyone, then many people would miss out on essential, potentially lifesaving information. To improve your ability to create accessible materials, the FEMA Digital Accessibility (508) Program will show you how you can create accessible documents. This webinar will showcase the built-in accessibility tools to assist document owners in creating accessible documents before posting online or distributing to others. Why? Because Digital Accessibility is everyone's responsibility!
31-Jul-24	Adapting to Change	Change can feel slow and almost imperceptible until a significant event occurs, revealing that things are no longer the same. It is important for local leaders and individuals to adopt a proactive stance in mitigating the rising future flood risk before it becomes too late. Time is a factor, and this presentation will explore how time can be both a liability and an asset. Property owners can draw lessons from the cautionary tale of iconic brands like Blockbuster and Sears, which failed to adapt to changes in the business environment, leading to their downfall. For community leaders, the evolution of societal attitudes toward safety regulations is evident over time, as illustrated by the historical successes of policies that took on drunk driving, seatbelt usage, and secondhand smoke. Perceiving future risk as a distant concern or denying that change is occurring can lead to complacency, inaction, and eventually missed opportunities. Local leaders and individuals can learn that sometimes, taking action is necessary to ensure they do not miss out on protecting lives and property.
7-Aug-24	IA Regulatory Changes	FEMA has amended its regulations governing the Individual Assistance program to simplify processes, remove barriers to entry and increase eligibility for certain types of assistance under the program. This is the first major reform of Individual Assistance regulations in over 20 years and is a key part of the administration and FEMA's efforts to transform and improve the experience of disaster survivors. These changes are a direct result of feedback received from disaster survivors, states, tribes and territories and other stakeholders regarding the challenges disaster survivors experience following disasters and looking at how to improve the survivor experience.
21-Aug-24	Avoiding Disaster Scams	Extreme weather and natural disasters can occur without warning, leaving you to make critical decisions when you may feel rushed. Scammers try to take advantage of that environment, preying on people before, during, and after disaster events. This webinar, presented by an attorney from the Federal Trade Commission's Northeast Regional Office, will help you spot, avoid, and report scams that you may encounter as you prepare for, deal with, and recover from extreme weather and other natural disasters.
28-Aug-24	Selfcare for Disaster Responders	Disaster Responders deal with the double burden of stress from home and work in the face of major disasters. Facing the difficult scenario of caring for themselves and others during this emergency presents responders with the risk of burnout, indirect trauma, and compassion fatigue. During this webinar, we will discuss the specific stressors for disaster responders as well as provide tools that can be used to promote self-care and aid in self-assessment.
4-Sep-24	Individual and Family Preparedness	FEMA Integration Team (FIT) Preparedness Liaisons from New York, New Jersey, Puerto Rico and the US Virgin Islands will discuss basic preparedness steps anyone can take as well as special considerations for hazards specific to each jurisdiction including hurricanes, flooding,

		earthquakes, tsunamis and extreme weather temperatures. This webinar will focus on general preparedness, pet preparedness, financial preparedness and building community resilience.
11-Sep-24	See Something, Say Something	The phrase “See Something, Say Something” is well known but do you know what it means? What are you supposed to see? and How do you say something when you see unusual or suspicious behavior? What is unusual or suspicious behavior? In this presentation, an Intel Analyst from NJOHSP will help define what specific behavior could be suspicious or unusual that should be reported to officials. It is vital to give law enforcement the opportunity to investigate any information provided to determine if the behavior could be a potential threat or terrorism related.
18-Sep-24	Active Shooter/Threat Guidance for Disability Service Providers	Our guest speaker, Andrew Perlman from New York City Emergency Management, will discuss actions a disability service provider can take to plan for this type of incident to ensure the safety of staff and clients. He will go over what to do in an active shooter/active threat situation, the roles of law enforcement, workplace management, and the disability community, and how to assess vulnerabilities.
16-Oct-24	CISA Active Shooter Guidance 2024	Preparing employees for a potential active shooter incident is an integral component of an organization’s incident response planning. Because active shooter incidents are unpredictable and evolve quickly, preparing for and knowing what to do in an active shooter situation can be the difference between life and death.
23-Oct-24	Navigating the Evolving Cyber Threat Landscape	The cyber threat environment, including the tactics and techniques used, is constantly evolving. New lures and scams are developed to target individuals, business, and organizations with the goal of siphoning funds, accessing accounts, and stealing information. As such, this presentation will cover those prevalent threats and tactics, ways to identify them, and how to protect ourselves from becoming victims of cybercrime.

6-Nov-24	BRIC Grant Application Tips	The Building Resilient Infrastructure and Communities (BRIC) grant program provides proactive investment in resilience for communities, so they are better prepared and remain resilient prior to a natural disaster. BRIC provides funds annually for hazard mitigation planning and projects to reduce risk of damage before a disaster. This webinar will provide an overview of BRIC and present tips for developing eligible and competitive sub-applications as well as provide best practices.

13-Nov-24	Creating Flood-Resilient Landscapes	Floods pose significant risk to human health and infrastructure. In communities near the ocean, flooding and flood risk are often associated with catastrophic coastal storms, such as hurricanes and nor'easters. However, flooding is not just a coastal problem.
